The Pre-bid Conference for the **Concreting of Farm to Market Roads (Package I and Package II) at Various Barangays in the Municipality of Dingras, Ilocos Norte** held at the Municipal Conference Hall, Dingras, Ilocos Norte, was called to order at 2:00 o'clock in the afternoon on July 13, 2018 and was presided by MARIANITA R. ALLADO, BAC Vice-Chairman.

BUSINESS MATTERS:

The BAC Vice-Chairman discussed the procedures on the submission of bids in consonance with the Revised Implementing Rules and Regulations of R.A. 9184.

She further explained that the instruction to Bidders including the Bid Data Sheet contained in the Bidding Documents is a good reference on the submission of Bids.

The Presiding Officer stressed that the *bidding procedure* must be strictly followed in accordance with relevant procedures for open competitive bidding as specified in the *Implementing Rules and Regulations (IRR) of Republic Act 9184*, otherwise known as the "Government Procurement Reform Act".


The Presiding Officer also informed the body that the *Bid Opening* shall be on July 25, 2018, 2:30 p.m. at the Conference Hall. The *Evaluation and Post Qualification of Bids* is scheduled for July 26-27, 2018.

It was agreed by PBA Ramos II and AB Taylan that even though Health and Safety is not included in the POW is just okay. The winning bidder will provide a Safety Officer during the construction period.


Then she also gave reminders on the warranty requirement of the contract and the offenses and penalties against erring bidders and officials.
