


WHEREAS, Brgys. Medina and Parado, situated in a low-lying terrain, where residences and build-up areas are directly hit by Bongo River;

WHEREAS, this local government unit cannot implement the aforesaid project due to its limited resources, hence, the dire need to earnestly request the national government to allocate fund under DPWH top priority flood control projects;
