WHEREAS, in consonance with the prescribed rules and law, a Special Permit should be secured in this Municipality for the conduct of the aforesaid activity;


WHEREAS, Bungcag Cockpit has its reputation of good standing as a business establishment;

RESOLVED FINALLY, to authorize the SB Secretary to transcribe this resolution and furnish copies to concerned authorities for consideration and approval.


