VILLANUEVA, SENATOR, REPUBLIC OF THE PHILIPPINES, TO GRANT AN ALLOCATION AMOUNTING TO TEN MILLION PESOS (PHP 10,000,000.00) FOR THE CONSTRUCTION OF A TWO- STOREY CLASSROOM BUILDING IN FAVOR OF THE DINGRAS EAST CENTRAL ELEMENTARY SCHOOL AT BARANGAY GUERRERO, DINGRAS, ILOCOS NORTE.


WHEREAS, education is an indispensable tool for the promotion of social change by molding the character and developing the values of an individual to become socially responsible and committed;

WHEREAS, our people through education will be aware about their rights and duties as well as their responsibilities, and how they can effectively contribute to society, hence, the promotion of self-empowerment and the preservation of national unity and social mindedness;

WHEREAS, the Municipality of Dingras, Ilocos Norte, in cognizance of the national government goals, is committed to provide earnest support to educational development of our constituents, particularly the children, to encourage and promote their potentials as value-oriented and socially mindful citizen of our community and the country as a whole;

WHEREAS, the Municipality, as a second-class Municipality, has no sufficient financial capability to fully implement its programs and projects pertaining to educational development, particularly in providing sufficient classrooms for conducive and effective learning activity of our teachers and pupils;

WHEREAS, adding burden to our educational concern, a school building in Dingras East Central Elementary School, located at Barangay Guerrero, Dingras, Ilocos Norte, was burned just recently, leaving the said school building totally damaged;



WHEREAS, by reason of our financial difficulties, there is a dire need to seek for the support and consideration of the national government, offices, and agencies for the construction a school building thereby preserving and enhancing the educational progress of our pupils;

WHEREAS, Hon. Joel C. Villanueva, Senator of the Republic of the Philippines, is known as a champion of education and self-empowerment, and who has deep concern for the development of local governments, especially those from small provinces like ours;

WHEREFORE, on motion of Hon. Benigno B. Dela Cruz duly seconded by Hon. Rowena Celerina P. Verzosa, it was

RESOLVED, as it is hereby resolved to respectfully and earnestly requesting Hon. Joel C. 




