A RESOLUTION TO AUTHORIZE THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A MEMORANDUM OF AGREEMENT FOR AND IN BEHALF OF THE MUNICIPALITY OF DINGRAS, ILOCOS NORTE WITH THE PROVINCIAL GOVERNMENT OF ILOCOS NORTE REPRESENTED BY THE HONORABLE GOVERNOR IMEE R. MARCOS, REGARDING THE ESTABLISHMENT OF PLAYGROUND AND FITNESS PARK IN THE MUNICIPALITY OF DINGRAS, ILOCOS NORTE.

WHEREAS, Sec. 22(c) of the Local Government Code defines the power of the Sangguniang Bayan to legalize the authority of the Local Chief Executive to enter into whatever contract concerning the local government unit;



WHEREAS, the Provincial Government of Ilocos Norte is pursuing a program for the provision of adequate service to ensure the health, fitness and welfare of its constituents;

WHEREAS, the Municipality of Dingras has expressed its desire and interest to use and develop the Dingras Public Plaza for the construction of a playground and fitness area;

RESOLVED, as it is hereby resolved to authorize the Local Chief Executive to enter into a Memorandum of Agreement for and in behalf of the Municipality of Dingras, Ilocos Norte with the Provincial Government of Ilocos Norte represented by the Honorable Governor Imee R. Marcos, regarding the establishment of playground and fitness park in the Municipality of Dingras, Ilocos Norte.



RESOLVED FINALLY, to authorize the SB Secretary to transcribe this resolution and furnish copies to all authorities concerned for their information.




