**WHEREAS**, the Office of the Sangguniang Bayan received a copy of the MDC Resolution No. 01 s.201;



**WHEREAS**, in consonance to Provincial Ordinance No. 009-2016, the Provincial Government of Ilocos Norte will hold a summer youth sports program;

**RESOLVED FINALLY**, to authorize the SB Secretary to transcribe this resolution and furnish copies to all authorities concerned for their information.




