WHEREAS, Section 25 (b) and (d) of the Local Government Code of 1991 defines the coordination and assistance of national government agencies to local government units;



WHEREAS, the insufficient supply of irrigation waters in farm lands in the Municipality of Dingras is the common perennial problem of the farmers;

WHEREAS, this local government unit cannot undertake the said project due to financial constraints;

WHEREFORE, on motion of Hon. Benigno B. Dela Cruz duly seconded by Hon. Charles L. Tadena, it was

RESOLVED, as it is hereby resolved to respectfully and earnestly request the National Irrigation Administration thru Hon. Dennis C. Laogan, Kabuhayan Partylist Representative, to allocate funds amounting to Four Million Pesos (Php. 4,000,000.00) for the rehabilitation of Elizabeth-Lanas-Barong Irrigation System, in the Municipality of Dingras, Ilocos Norte.




