RESOLVED FINALLY, to authorize the SB Secretary to transcribe this resolution and furnish copies to all authorities for their information.





SUBJECT: DPSC 01-2017 Anti-Theft of Fighting/Brood Cocks RE PNP LOI 71/08 "PAYAPA" (Decentralizing the Formulation and Implementation of Anti-Criminality Plans)

I. PURPOSE:

This Action Plan prescribes the general guidelines and procedures to be followed by Dingras Municipal Police Station, Local Government Unit of Dingras and all sectors concerned in the enforcement of laws and ordinances to focus the peace and order situation in the municipality of Dingras particularly on **Anti-Theft of Fighting/Brood Cocks**.

II. SITUATION:

A. General:

Cockfighting in the country has been a well-known pastime game for Local Filipinos, locally known as aficionados wherein the demand for fighting cocks have noticeably increased. Commonly, fighting cock/brood cocks were left unattended in the farm, backyard, rice field or graze land. These situations typically the finest time for perpetrators to cart away these livestock's. Despite of the various techniques, strategies to prevent any crime which being implemented by the Dingras Municipal Police Station, these illegal activities of lawless elements still prevail. The support and cooperation begins on the levels of the barangays, concerned community and residents itself to address this problem.

B. Assumption

It will be expected that number of perpetrators will gradually increase due to poverty and the increasing demands for ambition to have fighting and/or brood cocks and other livestock's.

III. MISSION:

The Dingras Municipal Police Station with its mission and statutory functions, and in coordination with the Local Government Unit (LGU) of Dingras, the League of Barangays, other law enforcement agencies and Non-Governmental Organizations (NGO's) shall strengthen its police operations to address all forms of illegal activities especially the Anti-Theft of Fighting/Brood Cocks Campaign in the municipality of Dingras.

IV. EXECUTION:

A. Concept of Operation:

The Dingras Municipal Police Station in coordination with other law enforcement agencies will conduct regular checkpoints established in strategic areas complemented by Brgy Tanods/BPATs to check those vehicles loaded with chicken, transported to other locality.

As part of its proactive measures the PNP will ascertain thru intelligence gathering the modus operandi of these lawless elements and to be extra vigilant by means of patrolling and Brgy visitation most especially in the areas with fighting/brood cock farms.

It should be coordinated to all barangay officials and inform all fighting/brood cock owners to practice preventive security measures to address the possible theft incidents on their area. Thus eliminating the chance of the lawless elements to do their illegal activities. All fighting/brood cock owners/managers shall register their chicken to their respective barangays. Likewise, all barangays shall have their respective records for the number of fighting cocks in and out of their barangay for the purpose of accounting and monitoring.

Spot inspection to be conducted to all cockfighting arena and poultry farms to check and verify all the documents of the legality of establishments.

a. OPERATION SECTION:

1. Monitor the implementation of this Action Plan.
2. Monitor the conduct of checkpoint and render report to the Officer In-Charge and Higher Office
3. Organize the composition of the personnel involve.
4. Deploy appropriate number of personnel to conduct police presence within strategic areas in AOR.
5. Conduct aggressive police operations for the neutralization of identified personalities involved in theft incidents of fighting/brood cocks.
6. Organized and activate the Association of Cockfighters and breeders in our locality and other NGOs as force multipliers.
7. Coordinate the managers/owners of the different Poultry Farms Cockfighting Arena and Cockfighters and Breeders Association of Ilocos Norte
8. Perform other task as directed.

b. INTEL SECTION:

1. To conduct monitoring in their possible hideouts and contacts.
2. To gather information as to their identities.
3. To identify buyer of fighting cocks.
4. To identify crime prone and strategic areas as basis for the conduct of checkpoints.
5. To conduct profiling of Fighting Cock breeders and other personalities engage in fighting cocks
6. To check the authenticity of fighting cocks records of the barangays.

7. To conduct inspection to all fighting cock farms regularly.
8. Provide timely and accurate intelligence information.
9. Perform other task as directed.

c. INVESTIGATION SECTION:

1. To investigate all cases referred.
2. To identify and file appropriate charges against criminals involve in theft incidents of fighting cocks.
3. To respect constitutional rights of all arrested suspects.
4. Coordinate with the court for the speedy prosecution of arrested suspects.
5. Perform other task as directed.

d. SUPPLY SECTION:

1. To provide gas allocation, communication equipment's and other supplies needed to ensure the smooth implementation of this LACAP.
2. Perform other task as directed.

e. PCR SECTION:

1. Responsible in the information drive to the populace of barangay thru text blast relayed to Punong Barangays.
2. Responsible in coordinating with the community and give timely information.
3. Coordination with all Punong Barangays for the mobilization of barangay Tanods/BPATs and BIN members in all barangays as force multipliers.
4. Proposed to proper authorities and conduct approved trainings for Barangay Intelligence Network/LSVP in information gathering efforts and reporting.
5. Organized Owners/Managers of Poultry farms and Cockfighting breeders of Dingras and initiate a signing of Memorandum of Agreement to poultry raiser and Cockfighting breeders for the effective and efficient implementation of the Action Plan
6. Perform other task is directed.

f. PATROLLERS

1. To conduct Mobile/MASCO, foot patrol, Oplan SITA Operations and other police operations to deter lawless elements in launching their illegal activities especially those who are engaged in cattle rustling activities.

g. Owners/Managers of Poultry Farms, Cockfighting Arena and Breeders of Cockfighting.

1. Provide appropriate supports in the implementation of this ACTION PLAN.
2. Responsible for registration of their establishments and keeping records of their fighting cocks.
3. To provide information to the PNP of any suspected illegal activities concerning fighting/brood cocks.

j.) BARANGAY PEACE AND ORDER COUNCIL:

- Mobilized Barangay Tanods/BPATs and BIN members.
- Provide information for the identification of persons involved in illegal activities concerning fighting cocks.
- To pass a resolution/ordinance requiring all poultry farm owners and breeders and owners of fighting cocks to register their establishments/farms and respective fighting cocks in their respective barangays in coordination with the LGU Dingras.
- To pass a resolution/ordinance requiring all poultry farm and cockfighting owners/breeders to get clearance and/or certification from the office of the Punong Barangay upon selling and transporting their fighting cocks and other poultry products.
- Provide appropriate supports in the implementation of this ACTION PLAN.

k.) DINGRAS MUNICIPAL PEACE AND ORDER COUNCIL

- Convene the Municipal Peace and Order Council members for inputs and subsequent approval of the Anti-Criminality Action Plan, taking into consideration the responsibility of all concerned, for a holistic and effective approach to the crime situation.
- To pass a resolution requiring all poultry farms and cockfighting owners and breeders to register their establishments/farms and their respective fighting cocks in their respective barangays in coordination with the LGU Dingras.
- To pass a resolution requiring all poultry farm and cockfighting owners/breeders to get clearance and/or certification from the office of the Chief Executive office upon selling and transporting their fighting cocks and other poultry products.
- Conduct assessment on the effectiveness of the plan and to make necessary adjustment as necessary.

l.) DINGRAS SANGGUNIANG BAYAN

- Enact ordinances for the adoption of the Municipal Peace and Order Council approved Anti-Criminality Action Plan, for the provisional funding and support of its implementation,
- Enact ordinance requiring all owners to register all fighting cocks at LGU-Dingras and even in the barangay for record and proper documentations.
- Enact ordinance requiring the poultry farm and cockfighting owners breeders to secure clearance from the office of the Punong Barangays and Office of the Local Chief Executive for upon selling and transporting of their fighting cocks and other related poultry products.
- Enact other ordinances as may be necessary or when the need arises, for the effective implementation of the plan.

C. Coordinating Instruction:

- Lateral coordination is encouraged.
- Police Operational Procedures (POPs) and SOPs must be strictly observed at all times.


V. **COMMAND AND SIGNAL:**

1. Command: Dingras Municipal Police Station
